



Release Notes: CPRD GOLD January 2021

Summary

An updated version of the CPRD GOLD database (data sourced from GP practices using Vision® GP software) is now available, which contains the following:

The following updates have been made to the January 2021 release.



Three Character Lookups

The following lookups have been added to the IMT three character lookup file: FLUQIVCOHP, FLUTIVOHP, COVCOURAGEOUS, FLUQIVCPHA, FLUQIVEOHP, FLUTIV, FLUTIVPHA, COVOTHER, FLUATIVOHP.

Changes to CPRD GOLD numbering convention

From the January 2021 build, CPRD GOLD will use the new five digit practice ID numbering convention, which will also affect the patient ID number. Customers are advised to check that any standard processing scripts used when processing data extracts will handle the updated version of pracid and patid.

Digital object identifier (DOI)

CPRD database releases for CPRD GOLD and CPRD Aurum now include a digital object identifier (DOI). The DOI links to information about the database version and how to cite the data in research findings. This update supports transparent, reproducible research and provides additional assurance of data provenance. In future, if you are using CPRD data that has a DOI, please cite this in any publications.
